Creating a Tribal Program Funded through the Department of Justice

Student evaluation will include evaluating the village needs in the context of a grant solicitation, developing programs based on a successful grant application, reporting, and grant close out.

Qualified Expert Witness for ICWA cases in state court

This course will focus on the Indian Child Welfare Act (ICWA) requirements for the state to provide Qualified Expert Witnesses (QEW) in certain proceedings of a child welfare case occurring in state courts. There will be discussion on the background for the QEW requirement, role of the QEW, how to prepare to be a QEW, what types of questions to expect, how to qualify as an expert witness, how to prepare a written report, and preparing for in-court testimony.

Tribal Appellate Court Development for Alaska Tribes
